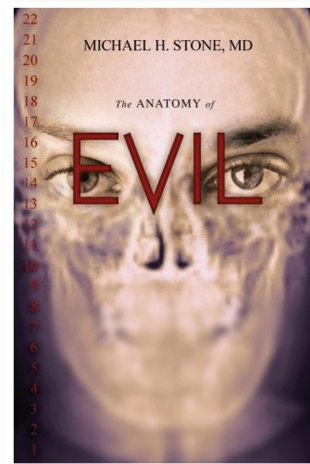

At the Extremes of Violence: Serial Killers, Mass Murder; Psychopathic & Sadistic Personality

MICHAEL H. STONE, MD

Professor of Clinical Psychiatry, Columbia College of Physicians and Surgeons

For twenty years, Dr. Stone has researched various forms of murder, focusing on serial sexual homicide, uxoricide, and mass murder. He hosted the Discovery Channel series entitled Most Evil, devoted to the exploration of the causative factors behind men and women committing murders that were accounted "evil" by the media and the general public. In this presentation, Dr. Stone discusses psychopathic and sadistic personality disorders in the case of serial killers, and paranoid personality, often with schizoid features, in the case of mass murder. Background factors, including genetic predisposition, head injury, substance abuse, and environmental factors are also addressed.

Institute Professor, Graduate School of Psychology, The Wright Institute

As political tides shift, exciting opportunities for rehabilitation abound. A huge population of individuals suffering from serious mental illness have been placed behind bars. This trend causes immense problems; at the same time it offers an opportunity to provide effective treatment and rehabilitation.

Dr. Kupers has served as consultant to Human Rights Watch, Amnesty International, and Stop Prisoner Rape, and has authored four books on forensic issues.

In this presentation, Dr. Lewis discusses neurological evolution of empathy and current scientific knowledge regarding abnormalities in neural emotion systems that promote, and perhaps cause, sociopathic traits and behavior.
