STALKING: THE STATE OF THE SCIENCE

J. Reid Meloy, PhD, Associate Clinical Professor of Psychiatry, UC San Diego;

President, Forensis, Inc.

Stalking is a serious criminal and public health problem. Drawing from his own research group, and the work of others', Dr. Meloy will present current data on the clinical, demographic, pursuit, diagnostic, threat, violence, and risk management aspects of stalking. The empirical research will be illustrated with both private and public figure stalking cases, and he will introduce a new typology of stalking called RECON. He will emphasize the concerns and skill building of forensic mental health professionals in this specialized area of knowledge.

J. Reid Meloy, PhD Presenter Spotlight

Dr. Reid Meloy is a diplomat in forensic psychology of the American Board of Professional Psychology. He was formerly Chief of the Forensic Mental Health Division for San Diego County and now devotes his time to a private civil and criminal forensic practice, research, writing, and teaching. He is an associate clinical professor of psychiatry at the UC San Diego School of Medicine; and an adjunct professor at the University of San Diego School of Law. He is also President of Forensis, Inc., a nonprofit, public benefit corporation devoted to forensic psychiatric and psychological research (www.forensis.org). Dr. Meloy has authored or co-authored over one hundred sixty papers published in peer-reviewed psychiatric psychological journals and has written or edited seven books. He is a sought after psychological expert on various criminal cases throughout the United States, and is currently a consultant to the counterintelligence division of the FBI and the United Kingdom's Home Office.

At the Sacramento County Jail, we have used the Structured Interview of Reported Symptoms (SIRS) to determine if inmates requesting a psychiatric appointment are exaggerating or malingering their symptoms. Currently, we have evaluated approximately 150 inmates who were referred for psychological testing to rule-out malingering. The relationship between the results on the SIRS and demographic factors, any past known psychiatric diagnoses, substance abuse, nature of offense, and possible motives for malingering psychosis will be examined.

This session will explore issues of confidentiality and ethics from two different perspectives: first, the mental health professional seeking to find the best long term solution for the client; second the criminal defense lawyer seeking to protect the liberty interests of the defendant.
