### **Narrative**

There is a national crisis in access to restoration treatment due to a rising number of people deemed Incompetent to Stand Trial (IST). In California, this crisis was made worse by the COVID-19 pandemic, which limited the transfer of individuals between facilities. Despite expanding capacity within DSH facilities, the waitlist and time until placement has remained high. The Department of State Hospitals (DSH) is implementing a range of potential solutions to this crisis, which include the Felony IST Re-Evaluation Program (Re-Evaluation Program).

The mission of Department of State Hospitals (DSH) Re-Evaluation Services is to re-evaluate Incompetent to Stand Trial (IST) individuals pending placement to DSH programs. Long-term data shows that approximately 33% (one third) of IST individuals admitted to DSH are already competent to stand trial at the time of their admission. The most common reasons for a change in a defendant's competency status is that a defendant has received psychiatric medication in county jail and regained trial competence. Other defendants regain trial competence when the effects of a substance wear off after several weeks in jail.

Experts conduct an in-depth re-evaluation of a defendant's competency status through video conferencing with IST individuals in county jails. Benefits of the program include allowing competent defendants to avoid further delays in their legal matters and more expedited admissions for the remaining incompetent individuals on the DSH waitlist who are most in need of hospital admission. Other benefits of the DSH IST Re Evaluation program include – but are not limited to – identification of individuals who may require involuntary medication (and medication consultation services through DSH), individuals who may be malingering, individuals who may have no substantial likelihood of restoration, or the identification of individuals who may be good candidates for diversion and other outpatient community programs.
