

## Mr. Flash Gordon

### Demographics

- 37 yo
- white
- earns \$80,000/yr
- resides in Sylmar
- non-religious

### Criminal History

- convicted of trespassing at night with respect to being on the campus of a woman's university, near the dorms
- when vehicle searched, 40 pornography magazines, and a collection of cut-out pictures of female children from magazines/newspapers/catalogs in a folder
- previous convictions for Indecent Act when caught masturbating in his vehicle, parked next to a playground in which children were present.
  - viewing an adult pornography magazine at the time of that offense
  - denied that his behaviour was motivated by sexual interest in children.

### Sexual History

- learned to masturbate at age 12 and daily pattern since, even when access to a sexual partner
- self-identified his problem as a pattern of compulsively masturbating in his vehicle rather than waiting until he had reached home.
- admits sexual arousal to pubescent female children
- regularly masturbates in car on way home from work
  - rationalized behaviour on the basis of needing "privacy" that did not exist at home.

### Living Situation:

- Resides in apartment at grandparents' home
- Daily contact with parents

### Family Relationships:

- Positive, per self-report and collateral reports from mother
- Family unaware of full details of his offence know only that he got "in trouble"

### Education and Employment:

- Liked school initially, became disinterested and dropped out after failing Grade Ten
- Completed GED; unsuccessful attempt at heavy-duty equipment operation ticket
- Other training in workplace safety
- History of manual labor,
- Currently employed in foundation formwork for 14 years
- Positive work ethic, enjoys job, boss's high regard
- Admits to past irresponsible spending, but manages major bills and maintains year-round employment

### Leisure and Social Life:

- Enjoys video games, spending time with friends, reading (fantasy/adventure), and gardening

### Substance Use:

- History of significant drug abuse; currently uses marijuana regularly but denies other illicit drug use
- Denies major problems with alcohol but began underage drinking and had police trouble related to alcohol
- High tobacco consumption, desires to quit due to cost
- Substance use not linked to inappropriate sexual behaviour

### Relationship History

- One live-in relationship starting at age 22
- Relationship lasted over a decade
- Separation occurred ~2 years prior to the current assessment
- Current status: Single
- Has a son with whom he maintains regular contact and demonstrates a strong parental bond

### **Mental Health History**

- no history of mental illness
- strong self-esteem
- high levels of attention-seeking and gregariousness
- did attend SOTP after previous offense—identified masturbation issue but denied paedophilic interests
- successfully completed and terminated when finished supervision.

### **Risk Assessment**

- PCL-R-low level of psychopathy
  - SORAG-low
  - Static-moderate-high
  - STABLE-moderate
  - LS/CMI-low
- Note: difference in results between the SORAG and Static instruments is due Static weighs sexual offence information more heavily
  - Mr. Gordon's offence was a non-contact offence involving child strangers (1st offense). Mr. Gordon does not meet a majority of the historical indicators for violent (including sexual) reoffence that are included on the SORAG.

### **Diagnosis**

- 302.2 Paedophilic Disorder (non-exclusive, sexually attracted to females)
- Query voyeurism paraphilia
- 305 Cannabis Use Disorder
- 304.20 Stimulant Use Disorder (cocaine; self-reported in sustained full remission)
